FINANCIAL CONDITIONS

United Community received an examination by the Texas Credit Union Department and an audit by Credit Union Resources Inc. in 2023. Both the audit and the examination showed us to be exemplary and confirmed that this is a sound financial institution with policies and procedures that fully comply with both federal and state regulations.

In addition, Bauer Financial Inc., a financial institution rating company, issued United Community a five-star rating in 2023. Our member deposits are insured up to \$250,000 by the NCUA, an agency of the federal government. The report of our financial condition as of December 31, 2023, is contained herein.
